## Scholarship/Financial Aid Policy

### General Information

ISC scholarships are granted on an annual basis. The number of scholarships and the scholarship amount is subject to available financial resources.

### Amount of Scholarship/financial aid

The maximum amount of a scholarship/financial aid is 2.600 EUR per year (260 EUR a month) per case and reduces the tuition fee.

### Duration of financial aid / Refund of received scholarship funds

Scholarship/Financial aid is granted for one school year only.

If a student, who receives financial aid, leaves ISC before the end of the school year, all scholarship funds which have been received must be returned to ISC without any deduction.

Scholarship funds have to be repaid to ISC if wrong or incomplete information was given during the application process.

### Criteria for awarding scholarship/financial aid

Additionally to a completed application form, an application letter and the proof of the economic situation of the applicant is required.

In general, scholarships/financial aids are awarded on the basis of social criteria.

The following income limits apply (gross):

- Annual income of a single parent with one child must not exceed EUR 30,000 (gross income)
- Annual income of families/partnerships with one child must not exceed EUR 37,000 per year (gross income).
- The limits for annual income increases by EUR 5,000 per year (gross) for each additional child living in the same household with the applicant.
- In the case of self-employment, the last available income tax return (not older than 2 years) will be used as information basis

### The following documents must be attached to the application:

- Application letter which explains the need for financial aid (outline your financial situation as basis of the scholarship application)
- Annual salary statement (pay slips for the year) or income tax return from the previous calendar year of all members of your household
- Information about pension payment (if applicable)

Additional Information

Application forms should be filled in and addressed to the ISC INTERNATIONAL SCHOOL CARINTHIA GmbH. **As of the school year 2023/24, applications have to be submitted until the 31<sup>st</sup> of March 2023 latest.**
